Victims of Crime Act (VOCA) - Megan Waters and Teresa Brechlin (Handout)

- Funding administered by the Utah Office for Victims of Crime for outreach and awareness efforts specifically related to crime victims and crime victims services.
- This is the first year they've offered funding under the Outreach and Awareness category.
- \$750,000 available per year for 2 years, ending in 2021.
- Proposing to implement statewide public awareness and outreach efforts to drive victims of sexual violence to services in their respective areas.

- Working with VOCA funded agencies to ensure adequate resources and preparation for the increase in need.
- Media partners will be included.
- VOCA local agencies include law enforcement agencies, domestic violence shelters, prosecutors, rape crisis, and family centers.
- Funds must go directly towards services for victims of crime, not prevention.
- \$750,000 total funds available but they are only applying for \$450,000.
- Funding requested are based off of media budget created by VIPP.
- The AG's office is also applying for funding to children's justice centers.
- Required match is 25% and can be both hard cash and in kind.
- Because these are Federal funds, not State funds, this will require further review by the applicants before applying.
- A follow up on the outcome of this application and funding is requested by Dr. Marc Babitz for Governance.
- Dr. Marc Babitz votes that this is exempt.

Grant Remains Exempt: No Vote Needed

Refugee Health Program - Danielle Rodriguez and Amelia Self (Handout)

- Application for the Refugee Health Promotion grant.
- Currently in the last year of a 3 year funding cycle awarded through the Office of Refugee Resettlement (ORR).
- Grant has been awarded in the past to provide classes on navigating the US healthcare system within the first year of newly arrived refugees resettlement.
- Commitment to ORR is to invite 100% of all newly arrived refugees into the 3 class series.
- To achieve this, they have contracted with the 2 resettlement agencies within the state to case manage all newly arrived refugees for 2 years.
- Benchmark and application to ORR is students retain attendance through all 3 classes.
- Resettlement agencies and case managers are helpful in knowing client schedule limitations and offer linguistic resources such as in person and telephonic interpreters.
- Evaluations include written pre and post assessments are administered to newly arrived refugees along with information from case managers and resettlement agencies about how self-sufficient clients are at managing their own health care.
- 100% of funding goes to the resettlement agencies.
- Goal is for client to complete all 3 classes of the series within the first year of settlement.
 - Often happens in 3 months or less.
- Contract benchmarks are based off the contract year to allow time to complete classes.
- This is a competitive grant.
- Grant has been received in the past. As long as budget allows, grant will likely be awarded.

Grant Remains Exempt: No Vote Needed

Collecting Violent Death Information Using the National Violent Death Reporting System (NVDRS) - Gary Mower (Handout)

- New 3 year grant through August 31, 2022.
- Same as the 5 year grant awarded in 2005. Due to year change, it is not a renewal.
- \$255, 822 for the first year.
- Purpose is to collect all information on violent deaths, enter information into a nationwide database and disseminate to key stakeholders in Utah to improve planning, implementation, and evaluation of violence prevention programs.
 - Violent deaths include homicides, suicides, unintentional firearm deaths, deaths from legal intervention, and undetermined deaths.
- 90% of funding goes towards personnel to collect and enter data from medical examiner and law enforcement reports as well as death certificates.
- All 50 states are funded.
- Grant is highly likely to be awarded.
- Once the current year has been closed out, information will be available to download from the national database. Anyone can download or request information and reports.
- Data and reports are broken down by specific topics.
- Gary Mower will send Lloyd Berentzen an electronic copy of report to share with health officers.
 - Suggestions for reporting:
 - Helpful to know Male or Female with method of injury.
 - Color coded maps by county.
 - Progression of changes.
- State summary can be broken down by area.
- Unsure about use of reports for local fatality reviews.
- Grant should be exempt, per Dr. Marc Babitz, as there is no money for locals and only one agency in the state can apply for it.
- Motion to accept this as an exempt grant by Dr. Marc Babitz.
- Dr. Marc Babitz requests this grant is brought to Governance every year to update members on progress and data.

Immunization and Vaccines for Children Grants - Rich Lakin

• New 5 year continuation. Prior year's grant will end June 30, 2019. July 1, 2019 starts new 5 year. Funding remains the same. \$3,542,485.00.

- Even though this is a continuation, this is applied for every year.
- Applying for level funding. Grant has been received in the past.
- A new adult immunizations category has been added. Adult immunizations were not previously supported by CDC.
- There are options to apply for more funding under separate grant categories.
- Grant is not based on population.
- Utah Vaccine Advisory is working on college requirements for young adults up to 55 years.
- Plan to apply for more categories next year.
- \$3,542,485 will be distributed amongst DOH personnel, fringe benefits, travel (Covers VFC reps and inspectors, travel to conferences, and trainings that CDC holds. Some are mandatory.)
- Reduced 2 full time employees within the Immunization program and reduced printing costs from about \$75,000-\$100,000 down to \$10,000 to preserve Immunization budget.
- Business managers and nursing directors and the health officers association should be involved in budgetary discussions.
