# Introduction

The Utah Department of Health (UDOH) Violence and Injury Prevention Program (VIPP) receives rape prevention and education funding from the U.S. Centers for Disease Control and Prevention. The funding is used to administer small contracts with community based organizations to provide sexual assault primary prevention programs in their communities. In addition to these programs, the VIPP established the first Statewide 24-hour Sexual Violence Crisis and Information Hotline in the Intermountain West in 1998.

Calls to the information hotline are routed, without interruption, to the nearest rape crisis program line based on where the call originates from in Utah. Currently there are 12 rape crisis programs linked to the information hotline. Callers may remain anonymous while obtaining information about resources available in their area.

## Summary of Findings

- From 2003-2008 the information line received more than 2,800 calls.
- The highest number of calls received during a one-year period occurred during 2006.
- From 2003-2008, the months during which the highest numbers of calls were recieved were September (n=284), July (n=281) and August (n=281).
- The counties that received the highest number of calls were Salt Lake (n=1101), Utah (n=311) and Davis (n=254).




# Findings

- From 2003-2008, the information line received 2,802 calls for an average of 467 calls per year (**Figure 1**).
- The majority of calls received during a one year period occurred during 2006 (n=595) (**Figure 1**).
- The lowest number of calls received during a one-year period occurred during 2003 (n=383) (**Figure1**).
- Throughout the six-year period the months during which the highest number of calls were received were September (n=284), July (n=281) and August (n=281) (**Figure2**).
- Throughout the six-year period the months during which the lowest number of calls were February (n=166), October (n=175) and December (n=184) (**Figure2**).











